PRIVACY POLICY

This Privacy Policy covers Spreadsheet Analysis use of personal information that Spreadsheet Analysis collects when you use the "website" means <http://www.investingcalculator.org>. The Privacy Policy also gives you information about cookies.

This Privacy Policy applies to all services, calculators and the website offered by Investingcalculator.org.

What information do we collect?

We collect information from you when you donate or contact us.

When donating, as appropriate, you may be asked to enter your PayPal account, so you can pay without giving away any credit card details. You may, however, visit our site anonymously.

What do we use your information for?

Any of the information we collect from you may be used in one of the following ways:

- * To send periodic emails

How do we protect your information?

After a transaction, your private information (email address, Paypal) will not be kept on file for more than 60 days.

Do we use cookies?

Yes (Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the sites or service providers systems to recognize your browser and capture and remember certain information

We use cookies to help us remember and process the items in your shopping cart, understand and save your preferences for future visits and compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future. We may contract with third-party service providers to assist us in better understanding our site visitors. These service providers are not permitted to use the information collected on our behalf except to help us conduct and improve our business.

Do we disclose any information to outside parties?

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential.
